



Aruba Central PowerPack Release Notes

Version 103

Overview

Version 103 of the Supplemental Device Class PowerPack includes updates to Dynamic Applications, scale optimization, and enhancements to Aruba Central API request rate limitation.

- **Minimum Required SL1 Version:** 10.2.0

Before You Install or Upgrade

Ensure that you are running version 10.2.0 or later of SL1 before installing *Aruba Central* version 103.

NOTE: For details on upgrading SL1, see the appropriate [Release Notes](#).

TIP: If you are currently using version 100 of the PowerPack, ScienceLogic strongly recommends completing a fresh installation of version 103 rather than upgrading. If you are currently using versions 101 and 102, then you can do a standard upgrade. The steps for both methods can be found below and in the *Monitoring Aruba Central* manual. Follow those procedures to ensure accurate data collection post-upgrade.

Installing or Upgrading the PowerPack

TIP: By default, installing a new version of a PowerPack will overwrite all content in that PowerPack that has already been installed on the target system. You can use the **Enable Selective PowerPack Field Protection** setting in the **Behavior Settings** page (System > Settings > Behavior) to prevent the new version of the PowerPack from overwriting local changes for some commonly customized fields.

NOTE: If you are currently using the Dynamic Applications in this PowerPack to monitor devices, collection errors might occur for one or two polling cycles during the installation of a new version. To prevent collection errors during an upgrade, you can optionally disable collection for monitored devices before performing the following steps and re-enable collection after the upgrade.

To install this PowerPack:

1. Familiarize yourself with the [Known Issues](#) for this release.
2. See the [Before You Install or Upgrade](#) section. If you have not done so already, upgrade your system to the 10.2.0 or later release.
3. Download the *Aruba Central* version 103 PowerPack from the Support Site to a local computer.
4. Go to the **PowerPack Manager** page (System > Manage > PowerPacks). Click the **[Actions]** menu and choose *Import PowerPack*. When prompted, import *Aruba Central* version 103.
5. Click the **[Install]** button. For details on installing PowerPacks, see the chapter on *Installing a PowerPack* in the **PowerPacks** manual.

For instructions on using the PowerPack, see the **Monitoring Aruba** manual.

Features

Version 103 of the *Aruba Central* PowerPack includes the following features:

- Dynamic Applications to discover and monitor Aruba Central component devices
- Device Classes for each of the Aruba Central components that the PowerPack can monitor
- Event Policies that are triggered when Aruba Central component devices meet certain status criteria
- A sample SOAP/XML Credential ("Aruba Central Example") that you can use to create your own Aruba Central Credential
- A Device Template ("Aruba Central Template") that aligns Dynamic Applications to the Aruba Central controller virtual device and enables you to discover component devices for that controller
- Device Dashboards that display information about Aruba Central component devices

Enhancements and Issues Addressed

The following enhancements and addressed issues are included in version 103 of the *Aruba Central* PowerPack:

- The "silo_aruba_central" content library was updated to optimize PowerPack performance at scale by reducing payload.
- Support for the Aruba Central API 7 calls per second request rate limitation was added to the PowerPack.
- The "Aruba Central Example" credential was updated based on Snippet Framework (silo-auth) requirements.
- The "silo_low_code" content library was added to support Snippet Framework.

- An issue was addressed in which discovery Dynamic Applications were failing due to rate limitations.
- An issue was addressed in which the "Aruba: Central Switch Discovery" configuration report was not displaying the model of switch devices.
- The following content libraries were removed:
 - silo_core
 - silo_core_rest
 - silo_credentials
- The following Dynamic Applications were disabled by default:
 - Aruba: Central Component Counts
 - Aruba: Central Notifications
 - REST: Performance Metrics Monitor (Aruba Central)
- The following Dynamic Applications were updated to use the "silo_low_code" content library:
 - Aruba: Central Switch Configuration
 - Aruba: Central Switch Container Discovery
 - Aruba: Central Switch Discovery
 - Aruba: Central Switch Performance
 - Aruba: Central SD-WAN Gateway Configuration
 - Aruba: Central SD-WAN Gateway Container Discovery
 - Aruba: Central SD-WAN Gateway Discovery
 - Aruba: Central SD-WAN Gateway Performance
 - Aruba: Central AP Configuration
 - Aruba: Central AP Container Discovery
 - Aruba: Central AP Discovery
 - Aruba: Central AP Performance

NOTE: Several collection objects were removed from the PowerPack in version 101. These collection objects no longer function in version 103, as their underlying collection code has been removed. Therefore, if you are upgrading to version 103 from version 100, you must either delete or modify the collection objects that were removed in version 101. If you delete them, you will lose any data they previously collected. Alternatively, you can modify them so they no longer have valid snippet arguments; doing so will retain the previously collected data. For more information, see the "Enhancements and Issue Addressed" section in the **Aruba Central version 101** release notes.

Known Issues

The following known issues affect version 103 of the Interface Billing PowerPack:

- The following widgets will not display data for the "Aruba: Central Controller," "Aruba: Wireless Access Points," "Aruba: Gateway Summary," "Aruba: Gateway," and "Aruba: Switches" SL1 dashboards because the Dynamic Applications "REST: Performance Metrics Monitor (Aruba Central)" and "Aruba: Central Component Counts" are disabled by default for this version:

- Requests (avg)
- Latency-Maximum, Minimum, Average (avg)
- SLL and Connection Errors (avg)
- Timeout (avg)
- Total Components
- AP Count
- Switch Count
- Gateway Count

Additionally, the following widgets on the "Aruba: Central Controller" Device Dashboard included in the PowerPack will not display data:

- Total Requests sent from EM7 to Aruba Central
- Error Response Count (Errors received back from Aruba Central)
- Total Access Points
- Total Switches
- Total Gateways

- A non-numeric value API-response, for the "Aruba: Central Switch Performance" collection objects, generates too many system log entries. An error message reads "Non-digits in oid with object id: <object_id>, did: <device_id> in dynamic app: <app_id> when updating performance value (val:-)". However, this does not affect data collection.
- Vitals metrics are displaying unusual labels for CPU and Memory Utilization metrics in the "Aruba: Central SD-WAN Gateway Performance" and "Aruba: Central Switch Performance" Dynamic Applications.
- An exception will be logged when the **Embed Value [%4]** field, in the credential, is left empty, contains a non-numeric value, or contains a value less than or equal to 0. SIGTERMS could be present on system logs as well.
- Time gaps may be present in the Performance Dynamic Applications after upgrading the PowerPack. If so, increase the Timeout seconds from 2 to 4 (or 5); but no more than that.
- The performance and configuration Dynamic Applications cannot run more frequently than their associated discovery Dynamic Applications.
- By default, configuration Dynamic Applications are set to display "Last Collected" data if a poll is missed. If you would like for the most recent value to display, set "--values" for the "Null Column Option" property.
- A known issue might cause Dynamic Application debug mode to fail in the SL1 user interface. To troubleshoot Dynamic Applications in version 103, ScienceLogic recommends using the command line debug mode on the Data Collector.
- The error messages for a device, during data collection, will not display on Device Logs, but device error messages will print on log files.

- A known issue causes Dynamic Applications to display information on reports even when the user credential has an incorrect username and password. This behavior will continue until the refresh token expires.
