Overview

Version 209 of the *Cisco: Base Pack PowerPack* includes many new Device Classes and updates to the "Cisco: FRU Control Configuration" Dynamic Application.

Before You Install or Upgrade

Ensure that you are running version 8.1.2 or later of the ScienceLogic platform before installing the *Cisco: Base Pack PowerPack* version 209.

NOTE: For details on upgrading the ScienceLogic platform, see the appropriate ScienceLogic Release Notes.

Installing or Upgrading to Cisco: Base Pack PowerPack version 209

To install the *Cisco: Base Pack PowerPack* for the first time or to upgrade from a previous version, perform the following steps:

TIP: By default, installing a new version of a PowerPack will overwrite all content in that PowerPack that has already been installed on the target system. You can use the **Enable Selective PowerPack Field Protection** setting in the **Behavior Settings** page (System > Settings > Behavior) to prevent the new version of the PowerPack from overwriting local changes for some commonly customized fields.

NOTE: If you are currently using the Dynamic Applications in the *Cisco: Base Pack* PowerPack to monitor devices, collection errors might occur for one or two polling cycles during the installation of a new version. To prevent collection errors during an upgrade, you can optionally disable collection for monitored devices before performing the following steps and re-enable collection after the upgrade.

1. See the [Before You Install or Upgrade](#) section. If you have not done so already, upgrade your system to the 8.1.2 or later release.
2. Download version 209 of the *Cisco: Base Pack* PowerPack from the Customer Portal to a local computer.
3. Go to the **PowerPack Manager** page (System > Manage > PowerPacks). Click the **[Actions]** menu and choose *Import PowerPack*. When prompted, import version 209 of the *Cisco: Base Pack* PowerPack.
4. After importing the PowerPack, you will be prompted to install the PowerPack. Click the **[Install]** button to install the PowerPack.
5. See the manual *Monitoring Switches, Routers, and Firewalls with SNMP* for instructions on using the PowerPack.

Features

Cisco: Base Pack version 209 includes the following features:

- Dynamic Applications that collect CPU, environmental status, memory, and basic configuration data for Cisco devices
- Event Policies that are triggered when Cisco devices meet certain status criteria
- Device Classes for each type of Cisco device monitored
- Sample credentials for discovering Cisco devices using SNMP
- A device dashboard that displays host resource, interface, and topology information for Cisco devices

Enhancements and Issues Addressed

The following enhancements and addressed issues are included in version 209 of the *Cisco: Base Pack* PowerPack:

- More than 140 new device classes were added to the PowerPack.
- The "Cisco: FRU Control Configuration" Dynamic Application was updated to:
 - add event policy descriptions
 - use consistent wording in alert messages
 - provide more granular detail in alert messages

Known Issues

The following are known issues that affect version 209 of the *Cisco: Base Pack PowerPack*:

- A known issue is causing false events to be triggered when a Dynamic Application collects cache data at the same time the cache is being updated.
