

Cisco: Intersight PowerPack Release Notes

Version 101

## Overview

Version 101 of the Cisco: Intersight PowerPack is the initial version of the PowerPack. With this PowerPack, you can monitor your Cisco: Intersight devices in real time. This PowerPack supports Python 3 (PY3).

# Before You Install or Upgrade

Ensure that you are running version 11.3.0 or later of SL1 before installing "Cisco: Intersight" PowerPack version 101.

NOTE: For details on upgrading SL1, see the relevant SL1 Platform Release Notes.

# Installation and Upgrade Process

**NOTE**: If you are currently using the Dynamic Applications in this PowerPack to monitor devices, collection errors might occur for one or two polling cycles during the installation of a new version. To prevent collection errors during an upgrade, you can optionally disable collection for monitored devices before performing the following steps and re-enable collection after the upgrade.

### To install this PowerPack:

- Search for and download the PowerPack from the PowerPacks page (Product Downloads > PowerPacks & SyncPacks) at the <u>ScienceLogic Support Site</u>.
- 2. In SL1, go to the **PowerPacks** page (System > Manage > PowerPacks).
- 3. Click the Actions menu and choose Import PowerPack. The Import PowerPack modal appears.
- 4. Click [Browse] and navigate to the PowerPack file from step 1.
- 5. Select the PowerPack file and click [Import]. The PowerPack Installer modal displays a list of the PowerPack contents.
- 6. Click [Install]. The PowerPack is added to the PowerPack Manager page.

  - Cisco: Intersight Organization Discovery
  - Cisco: Intersight Rack Unit Configuration
  - o Cisco: Intersight Rack Unit Discovery
- Device Classes for each type of monitored Cisco: Intersight device:
  - Account
  - Blade Servers
  - Chassis
  - Fabric Interconnect
  - Organization
  - RackUnit
- Event Policies and corresponding alerts that are triggered when Cisco: Intersight devices meet certain status criteria

# Enhancements and Issues Addressed

The following enhancements and addressed issues are included in version 101 of the "Cisco: Intersight" PowerPack:

- Updated the "silo apps" library to version 5.1.5.
- The "Cisco: Intersight" PowerPack version 101 now supports proxy settings on existing login credentials.

**NOTE**: If you are upgrading this PowerPack from a previous version, it is necessary to create a new Universal Credential with proxy settings.

## Known Issues

The following known issues affect version 101 of the Cisco: Intersight PowerPack:

• An error message similar to the one below displays when executing any Cisco: Intersight " Dynamic Application in debug mode.
