



Cisco: Intersight PowerPack Release Notes

Version 101

Overview

Version 101 of the *Cisco: Intersight* PowerPack is the initial version of the PowerPack. With this PowerPack, you can monitor your Cisco: Intersight devices in real time. This PowerPack supports Python 3 (PY3).

Before You Install or Upgrade

Ensure that you are running version 11.3.0 or later of SL1 before installing "Cisco: Intersight" PowerPack version 101.

NOTE: For details on upgrading SL1, see the relevant [SL1 Platform Release Notes](#).

Installation and Upgrade Process

NOTE: If you are currently using the Dynamic Applications in this PowerPack to monitor devices, collection errors might occur for one or two polling cycles during the installation of a new version. To prevent collection errors during an upgrade, you can optionally disable collection for monitored devices before performing the following steps and re-enable collection after the upgrade.

To install this PowerPack:

1. Search for and download the PowerPack from the **PowerPacks** page (Product Downloads > PowerPacks & SyncPacks) at the [ScienceLogic Support Site](#).
2. In SL1, go to the **PowerPacks** page (System > Manage > PowerPacks).
3. Click the **Actions** menu and choose *Import PowerPack*. The **Import PowerPack** modal appears.
4. Click **[Browse]** and navigate to the PowerPack file from step 1.
5. Select the PowerPack file and click **[Import]**. The **PowerPack Installer** modal displays a list of the PowerPack contents.
6. Click **[Install]**. The PowerPack is added to the **PowerPack Manager** page.

 - Cisco: Intersight Alarms Configuration
 - Cisco: Intersight Blade Server Configuration
 - Cisco: Intersight Blade Server Discovery
 - Cisco: Intersight Chassis Configuration
 - Cisco: Intersight Chassis Discovery
 - Cisco: Intersight Fabric Interconnect Configuration
 - Cisco: Intersight Fabric Interconnect Discovery
 - Cisco: Intersight Organization Discovery
 - Cisco: Intersight Rack Unit Configuration
 - Cisco: Intersight Rack Unit Discovery
- Device Classes for each type of monitored Cisco: Intersight device:
 - Account
 - Blade Servers
 - Chassis
 - Fabric Interconnect
 - Organization
 - RackUnit
- Event Policies and corresponding alerts that are triggered when Cisco: Intersight devices meet certain status criteria

Enhancements and Issues Addressed

The following enhancements and addressed issues are included in version 101 of the "Cisco: Intersight" PowerPack:

- Updated the "silo_apps" library to version 5.1.5.
- The "Cisco: Intersight" PowerPack version 101 now supports proxy settings on existing login credentials.

NOTE: If you are upgrading this PowerPack from a previous version, it is necessary to create a new Universal Credential with proxy settings.

Known Issues

The following known issues affect version 101 of the Cisco: *Intersight* PowerPack:

- An error message similar to the one below displays when executing any Cisco: Intersight " Dynamic Application in debug mode.
