#### Overview

Version 102 of the Datacenter Advanced Enrichment: Cisco IOS Policies PowerPack enables the option for users to manually trigger the included automation policies from the event console.

## Before You Install

Ensure that you are running version 10.1.0 or later of SL1 before installing the *Datacenter Advanced Enrichment:* Cisco IOS Policies PowerPack version 102.

**NOTE**: You must install version 102 of the *Datacenter Advanced Enrichment Actions* PowerPack before continuing.

NOTE: For details on upgrading SL1, see the appropriate ScienceLogic Release Notes.

## Installation Process

To install version 102 of the Datacenter Advanced Enrichment: Cisco IOS Policies PowerPack:

- 1. See the **Before You Install** section. If you have not done so already, upgrade your system to the 10.1.0 or later release.
- 2. Download the Datacenter Advanced Enrichment: Cisco IOS Policies version 102 PowerPack to a local computer.
- 4. Go to the **PowerPack Manager** page (System > Manage > PowerPacks). Click the **[Actions]** menu and choose *Import PowerPack*. Import the *Datacenter Advanced Enrichment*: Cisco IOS Policies version 102 PowerPack. For details on importing PowerPacks, see the chapter on *Installing a PowerPack* in the **PowerPacks** manual.
- 5. Click the [Install] button. For details on installing PowerPacks, see the chapter on Installing a PowerPack in the PowerPacks manual.

### **Features**

The following features are included in version 102 of the Datacenter Advanced Enrichment: Cisco IOS Policies PowerPack:

- 73 Automation Policies that you can configure to collect additional diagnostic information when events occur.
- 180 Event Policies that you can use with the Automation Policies that are triggered when Cisco IOS devices meet certain status criteria.

### Enhancements and Issues Addressed

The following changes are included in version 102 of the Datacenter Advanced Enrichment: Cisco IOS Policies PowerPack:

• All automation policies have been updated to change the "Policy Type" field from "Active Events" to "Active Events/User Initiated".
