Overview

Version 100 is the initial version of the Datacenter Advanced Enrichment: Cisco IOS-XE Policies PowerPack. This PowerPack introduces 32 new Automation Policies and 72 Event Policies that you can use with the Datacenter Advanced Enrichment Actions PowerPack.

Before You Install

Ensure that you are running version 8.10.0 or later of SL1 before installing the Datacenter Advanced Enrichment: Cisco IOS-XE Policies PowerPack version 100.

NOTE: For details on upgrading SL1, see the appropriate ScienceLogic Release Notes.

Installation Process

To install version 100 of the Datacenter Advanced Enrichment: Cisco IOS-XE Policies PowerPack:

- 1. See the **Before You Install** section. If you have not done so already, upgrade your system to the 8.10.0 or later release.
- 2. Download the Datacenter Advanced Enrichment: Cisco IOS-XE Policies version 100 PowerPack to a local computer.
- 4. Go to the **PowerPack Manager** page (System > Manage > PowerPacks). Click the **[Actions]** menu and choose *Import PowerPack*. Import the *Datacenter Advanced Enrichment: Cisco IOS-XE Policies* version 100 PowerPack. For details on importing PowerPacks, see the chapter on *Installing a PowerPack* in the **PowerPacks** manual.
- 5. Click the [Install] button. For details on installing PowerPacks, see the chapter on Installing a PowerPack in the PowerPacks manual.

- 32 Automation Policies that you can configure to collect additional diagnostic information when events occur.
- 72 Event Policies that you can use with the Automation Policies that are triggered when Cisco IOS devices meet certain status criteria.
