### Overview

Version 100 is the initial version of the Datacenter Advanced Enrichment: Cisco Networking Policies PowerPack. This PowerPack introduces 27 Automation Policies and 20 Event Policies that you can use with the Datacenter Advanced Enrichment Actions PowerPack.

# Before You Install

Ensure that you are running version 8.10.0 or later of SL1 before installing the Datacenter Advanced Enrichment: Cisco Networking Policies PowerPack version 100.

# Installation Process

To install version 100 of the Datacenter Advanced Enrichment: Cisco Networking Policies PowerPack:

- 1. See the **Before You Install** section. If you have not done so already, upgrade your system to the 8.10.0 or later release.
- 2. Download the Datacenter Advanced Enrichment: Cisco Networking Policies version 100 PowerPack to a local computer.
- 4. Go to the PowerPack Manager page (System > Manage > PowerPacks). Click the [Actions] menu and choose Import PowerPack. Import the Datacenter Advanced Enrichment: Cisco Networking Policies version 100 PowerPack. For details on importing PowerPacks, see the chapter on Installing a PowerPack in the PowerPacks manual.
- 5. Click the **[Install]** button. For details on installing PowerPacks, see the chapter on *Installing a PowerPack* in the **PowerPacks** manual.
- 6. See the **Datacenter Advanced Enrichment Policies PowerPacks** for instructions on using the new PowerPack.

- 27 Automation Policies that you can configure to collect additional diagnostic information when events occur.
- 20 Event Policies that you can use with the Automation Policies that are triggered when Cisco Networking devices meet certain status criteria.
