

Cisco NX Automation Policies PowerPack Release Notes

Version 101

Overview

Version 101 of the Cisco NX Automation Policies PowerPack updates the PowerPack name and updates the default Policy Type of the included automation policies.

Before You Install

Ensure that you are running version 10.1.0 or later of SL1 before installing Cisco NX Automation Policies version 101.

NOTE: For details on upgrading SL1, see the appropriate Release Notes.

Installation Process

To install this PowerPack:

- 1. Familiarize yourself with the **Known Issues** for this release.
- 2. See the **Before You Install or Upgrade** section. If you have not done so already, upgrade your system to the 10.1.0 or later release.
- 3. Download the Cisco NX Automation Policies version 101 PowerPack from the Support Site to a local computer.
- 4. Go to the **PowerPack Manager** page (System > Manage > PowerPacks). Click the **[Actions]** menu and choose *Import PowerPack*. When prompted, import Cisco NX Automation Policies version 101.
- 5. Click the [Install] button. For details on installing PowerPacks, see the chapter on Installing a PowerPack in the PowerPacks manual.

Features

Version 101 of the Cisco NX Automation Policies PowerPack includes the following features:

- Two Automation Policies that you can configure to collect additional diagnostic information when events
 occur.
- Two Event Policies that you can use with the Automation Policies that are triggered when Cisco NX-OS devices meet certain status criteria.

Enhancements and Issues Addressed

The following enhancements and addressed issues are included in version 101 of the Cisco NX Automation Policies PowerPack:

- The PowerPack was renamed "Cisco NX Automation Policies".
- The default Policy Type of the automation policies included in the PowerPack were updated to "Active Events/User Initiated".
