Overview

Version 100 of the Cisco: TelePresence: Traps PowerPack is an upgrade to version 7.3.6. This version removes several Event Policies that are now included in a different PowerPack.

- Minimum Required Platform Version: 8.4.2
- Support Status: GA

Before You Install or Upgrade

Ensure that you are running version 8.4.2 or later of the ScienceLogic platform before installing the Cisco: *TelePresence: Traps* PowerPack version 100.

NOTE: For details on upgrading the ScienceLogic platform, see the appropriate ScienceLogic Release Notes.

Installing or Upgrading to Cisco: TelePresence: Traps PowerPack version 100

To install the Cisco: TelePresence: Traps PowerPack for the first time or to upgrade from a previous version, perform the following steps:

- 1. If you have not done so already, upgrade your system to the 8.4.2 or later release.
- 2. Download version 100 of the Cisco: TelePresence: Traps PowerPack from the Customer Portal to a local computer.
- Go to the PowerPack Manager page (System > Manage > PowerPacks). Click the [Actions] menu and choose Import PowerPack. When prompted, import version 100 of the Cisco: TelePresence: Traps PowerPack.
- 4. After importing the PowerPack, you will be prompted to install the PowerPack. Click the **[Install]** button to install the PowerPack.

Included Features

The following features are included in version 100 of the Cisco: TelePresence: Traps PowerPack:

• Event Policies to monitor Cisco TelePresence endpoints and infrastructure devices that are configured to send SNMP traps.

Enhancements and Issues Addressed

The following enhancements and addressed issues are included in version 100 of the Cisco: TelePresence: Traps PowerPack:

- The Cisco Unified Border Element (CUBE) Service Provider Edition is now supported by version 101 of the Cisco: UC Ancillary PowerPack, which includes Event Policies for the devices' SNMP traps. Because of this change, the following duplicate Event Policies were removed from the Cisco: TelePresence: Traps PowerPack and will be force-removed when you upgrade to version 100:
 - Cisco: TP: SBC Adjacency Status
 - Cisco: TP: SBC Adjacency Status Attached
 - Cisco: TP: SBC Adjacency Status Detached
 - Cisco: TP: SBC Dynamic Black List Event
 - Cisco: TP: SBC Radius Connection Status
 - Cisco: TP: SBC Service State Event
 - Cisco: TP: SBC SLA Violation
 - Cisco: TP: SBC Source Alert Event
 - Cisco: TP: SBC System Congestion Event
