Before You Install

Ensure that you are running version 10.1.0 or later of SL1 before installing Cisco UCS Automation Policies version 101.

NOTE: For details on upgrading SL1, see the appropriate Release Notes.

Installation Process

To install this PowerPack:

- 1. Familiarize yourself with the **Known Issues** for this release.
- 2. See the **Before You Install or Upgrade** section. If you have not done so already, upgrade your system to the 10.1.0 or later release.
- 3. Download the Cisco UCS Automation Policies version 101 PowerPack from the Support Site to a local computer.
- 4. Go to the **PowerPack Manager** page (System > Manage > PowerPacks). Click the **[Actions]** menu and choose *Import PowerPack*. When prompted, import Cisco UCS Automation Policies version 101.
- 5. Click the [Install] button. For details on installing PowerPacks, see the chapter on Installing a PowerPack in the PowerPacks manual.

Version 101 of the Cisco UCS Automation Policies PowerPack includes the following features:
