Version 100 of the Cisco: Unity Express PowerPack adds the ability to monitor configuration data and performance metrics from F5 BIG-IP, and includes multiple enhancements.

Installation Process

To install version 100 of the Cisco: Unity Express PowerPack, perform the following steps:

- 1. If you have not done so already, upgrade your system to the 7.8.0 or later release.
- 2. Download version 100 of the Cisco: Unity Express PowerPack from the Customer Portal to a local computer.
- 3. Go to the **PowerPack Manager** page (System > Manage > PowerPacks). Click the Actions menu and choose *Import PowerPack*. When prompted, import version 100 of the Cisco: Unity Express PowerPack.
- 4. After importing the PowerPack, you will be prompted to install the PowerPack. Click the Install button to install the PowerPack.

Version 100 of the Cisco: Unity Express PowerPack is a new PowerPack for monitoring Cisco: Unity Express devices.
