

# Citrix NetScaler Automation Policies PowerPack Release Notes

Version 101

### Overview

Version 101 of the Citrix Netscaler Automation Policies PowerPack updates the PowerPack name and the default Policy Type of the included automation policies.

# Before You Install

Ensure that you are running version 10.1.0 or later of SL1 before installing Citrix Netscaler Automation Policies version 101.

NOTE: For details on upgrading SL1, see the appropriate Release Notes.

### Installation Process

To install this PowerPack:

- 1. Familiarize yourself with the Known Issues for this release.
- 2. See the **Before You Install or Upgrade** section. If you have not done so already, upgrade your system to the 10.1.0 or later release.
- 3. Download the Citrix Netscaler Automation Policies version 101 PowerPack from the Support Site to a local computer.
- 4. Go to the **PowerPack Manager** page (System > Manage > PowerPacks). Click the **[Actions]** menu and choose Import PowerPack. When prompted, import Citrix Netscaler Automation Policies version 101.
- 5. Click the **[Install]** button. For details on installing PowerPacks, see the chapter on *Installing a PowerPack* in the **PowerPacks** manual.

See the Datacenter Advanced Enrichment Policies PowerPacks for instructions on using the new PowerPack.

### Features

Version 101 of the Citrix Netscaler Automation Policies PowerPack includes the following features:

- Automation policies that you can configure to collect additional diagnostic information when events occur.
- Event policies that are triggered when Citrix NetScaler devices meet certain status criteria.

The following enhancements and addressed issues are included in version 101 of the Citrix Netscaler Automation *Policies* PowerPack:

- The PowerPack was renamed "Citrix Netscaler Automation Policies".
