Overview

Version 105 of the *Datacenter Advanced Enrichment Actions* PowerPack updates SSH/telnet sessions to default to use the lowest privilege possible.

- **Minimum Required Platform Version:** 8.10.0

Before You Install

Ensure that you are running version 8.10.0 or later of SL1 before installing *Datacenter Advanced Enrichment Actions* version 105.

NOTE: For details on upgrading SL1, see the appropriate [Release Notes](#).

NOTE: The Datacenter Advanced Enrichment PowerPack must be installed last after any automation PowerPacks have been installed.

Installation Process

To install or upgrade the *Datacenter Advanced Enrichment Actions* PowerPack, perform the following steps:

1. Familiarize yourself with the [Known Issues](#) for this release.
2. If you have not done so already, upgrade your system to the 8.10.0 or later release.
3. Download version 105 of the *Datacenter Advanced Enrichment Actions* PowerPack from the Support Site to a local computer.
4. Go to the **PowerPack Manager** page (System > Manage > PowerPacks). Click the **Actions** menu and choose *Import PowerPack*. When prompted, import version 105 of the *Datacenter Advanced Enrichment Actions* PowerPack.
5. After importing the PowerPack, you will be prompted to install the PowerPack. Click the Install button to install the PowerPack.

See the *Datacenter Advanced Enrichment Actions PowerPacks* for instructions on using the PowerPack.

Features

This PowerPack contains a set of automation actions that provide a framework for executing SSH and Telnet commands remotely on a variety of devices, and then formatting the result. There are 348 automation actions that build different lists of diagnostic commands to be executed by the framework. This PowerPack is a prerequisite installation for the Automation Policy PowerPacks or can be used to build custom Automation Policies.

Enhancements and Issues Addressed

The following enhancements and addressed issues are included in version 105 of the *Datacenter Advanced Enrichment Actions* PowerPack:

- SSH/telnet sessions created by the "Enrichment Util: Collect Enrichment Data" automation action were updated to default to use the lowest privilege possible, therefore the sessions no longer default to escalate to privilege mode. The option to escalate privileges on a per-automation basis has been set.
