## Overview

Version 106 of the *Datacenter Advanced Enrichment Actions* PowerPack includes security updates.

## Before You Install

Ensure that you are running version 8.10.0 or later of SL1 before installing *Datacenter Advanced Enrichment Actions* version 106.

**NOTE:** For details on upgrading SL1, see the appropriate [Release Notes](#).

**NOTE:** The *Datacenter Advanced Enrichment* PowerPack must be installed last after any automation PowerPacks have been installed.

## Installation Process

To install or upgrade the *Datacenter Advanced Enrichment Actions* PowerPack, perform the following steps:

1. Familiarize yourself with the [Known Issues](#) for this release.
2. See the [Before You Install or Upgrade](#) section. If you have not done so already, upgrade your system to the 8.10.0 or later release.
3. Download the *Datacenter Advanced Enrichment Actions* version 106 PowerPack from the Support Site to a local computer.
4. Go to the **PowerPack Manager** page (System > Manage > PowerPacks). Click the **[Actions]** menu and choose *Import PowerPack*. When prompted, import *Datacenter Advanced Enrichment Actions* version 106.
5. Click the **[Install]** button. For details on installing PowerPacks, see the chapter on *Installing a PowerPack* in the **PowerPacks** manual.

## Features

This PowerPack contains a set of automation actions that provide a framework for executing SSH and Telnet commands remotely on a variety of devices, and then formatting the result. There are 348 automation actions that build different lists of diagnostic commands to be executed by the framework. This PowerPack is a prerequisite installation for the Automation Policy PowerPacks or can be used to build custom Automation Policies.

## Enhancements and Issues Addressed

The following enhancements and addressed issues are included in version 106 of the *Datacenter Advanced Enrichment Actions* PowerPack:

- Logging was updated in the PowerPack to improve security.
- Security updates were made to be compatible with the upcoming SL1 version 11.1.0 release.
