## Overview

Version 203 of the "Dell EMC: VMAX and PowerMax Unisphere API" PowerPack updates the PowerPack for Guided Discovery and Python 3 compatibility.

## Before You Install or Upgrade

Ensure that you are running version 12.1 or later of SL1 before installing the "Dell EMC: VMAX and PowerMax Unisphere API" PowerPack.

NOTE: For details on upgrading SL1, see the relevant SL1 Platform Release Notes.

## Installation or Upgrade Process

To install version 203 of the "Dell EMC: VMAX and PowerMax Unisphere API" PowerPack, perform the following steps:

**CAUTION**: You cannot upgrade to Version 203 of the "Dell EMC: VMAX and PowerMax Unisphere API" PowerPack from the *Dell EMC*: VMAXPowerPack. You must freshly install this version and run a new discovery session.

To install this PowerPack:

- 1. Familiarize yourself with the Known Issues for this release.
- 2. See the **Before You Install or Upgrade** section. If you have not done so already, upgrade your system to the 12.1 or later release.
- 3. Download the "Dell EMC: VMAX and PowerMax Unisphere API" version 203 PowerPack from the Support Site to a local computer.

- Go to the PowerPack Manager page (System > Manage > PowerPacks). Click the [Actions] menu and choose Import PowerPack. When prompted, import "Dell EMC: VMAX and PowerMax Unisphere API" version 203.
- 5. Click the **[Install]** button. For details on installing PowerPacks, see the chapter on *Installing a PowerPack* in the **PowerPacks** manual.
