

# SL1 IBM: Tivoli Storage Manager PowerPack Release Notes

Version 102

### Overview

Version 102 of the *IBM*: *Tivoli Storage Manager* PowerPack introduces a security enhancement to the PowerPack's Dynamic Applications.

# Before You Install or Upgrade

Ensure that you are running version 8.14.1 or later of SL1 before installing *IBM*: *Tivoli Storage Manager* version 102.

**NOTE**: For details on upgrading SL1, see the appropriate Release Notes.

## Installation or Upgrade Process

To install version 102 of the IBM: Tivoli Storage Manager PowerPack, perform the following steps:

- 1. Familiarize yourself with the **Known Issues** for this release.
- 2. See the **Before You Install or Upgrade** section. If you have not done so already, upgrade your system to the 8.14.1 or later release.
- 3. Search for and download the *IBM*: Tivoli Storage Manager PowerPack from the **PowerPacks** page on the ScienceLogic Support Site.
- 4. In SL1, go to the **PowerPack Manager** page (System > Manage > PowerPacks).
- 5. Click the [Actions] button and choose Import PowerPack. The Import PowerPack modal appears.
- 6. Click [Browse] and navigate to the PowerPack file from step 3.
- 7. Select the PowerPack file and click [Import]. The PowerPack Installer modal page displays a list of the PowerPack contents.
- 8. Click [Install]. After the installation is complete, the PowerPack appears on the PowerPack Manager page.
