## Before You Install or Upgrade

Ensure that you are running version 12.1.2 or later of SL1 before installing "IBM: Tivoli Storage Manager" PowerPack version 103.

## Installation or Upgrade Process

To install version 103 of the IBM: Tivoli Storage Manager PowerPack, perform the following steps:

To install this PowerPack:

- 1. Familiarize yourself with the *Known Issues* for this release.
- 2. See the **Before You Install or Upgrade** section. If you have not done so already, upgrade your system to the 12.1.2 or later release.
- 3. Download the "IBM: Tivoli Storage Manager" version 103 PowerPack from the Support Site to a local computer.
- 4. Go to the **PowerPack Manager** page (System > Manage > PowerPacks). Click the **[Actions]** menu and choose *Import PowerPack*. When prompted, import "IBM: Tivoli Storage Manager" version 103.
- 5. Click the [Install] button. For details on installing PowerPacks, see the chapter on Installing a PowerPack in the PowerPacks manual.

See the manual Monitoring IBM Tivoli Storage Manager for instructions on using the PowerPack.
