Ensure that you are running version 12.1.2 or later of SL1 before installing "IBM: Tivoli Storage Manager" PowerPack version 103.

To install version 103 of the *IBM: Tivoli Storage Manager PowerPack*, perform the following steps:

To install this PowerPack:

1. Familiarize yourself with the [Known Issues](#) for this release.
2. See the [Before You Install or Upgrade](#) section. If you have not done so already, upgrade your system to the 12.1.2 or later release.
3. Download the "IBM: Tivoli Storage Manager" version 103 PowerPack from the Support Site to a local computer.
4. Go to the **PowerPack Manager** page (System > Manage > PowerPacks). Click the **[Actions]** menu and choose *Import PowerPack*. When prompted, import "IBM: Tivoli Storage Manager" version 103.
5. Click the **[Install]** button. For details on installing PowerPacks, see the chapter on *Installing a PowerPack* in the **PowerPacks** manual.

See the manual *Monitoring IBM Tivoli Storage Manager* for instructions on using the PowerPack.
