## Before You Install or Upgrade

Ensure that you are running version 11.1.0 or later of SL1 before installing Interface Billing version 101.

**NOTE:** This PowerPack is included with the 11.3.0 ISO installation, but you may upgrade your Interface Billing dashboard if you are running on 11.1.0 or 11.2.0.

## Enhancements and Issues Addressed

The following enhancements and addressed issues are included in version 101 of the Interface Billing PowerPack:

- Improved organization restrictions on user visibility for the widgets on the Interface Billing dashboard to ensure widgets display the correct information relevant to the **Interface Billing Policy** selected in the **Context Driver** widget.

## Known Issues

The following known issues affect version 101 of the Interface Billing PowerPack:

- A known issue might cause widgets on the Interface Billing dashboard to display information about different Interface Billing policies. This behavior is a result of a context driver issue when there are more than one Interface Billing Policies aligned to one organization.
