

Jira Service Management Automation Policies PowerPack

Release Notes Version 100

Overview

Version 100 of the "Jira Service Management Automation Policies" PowerPack is the initial version of the PowerPack. This PowerPack introduces an example credential, run book automation policies, and run book action policies.

This PowerPack works in conjunction with the "Jira Service Management" SyncPack.

Before You Install

Ensure that you are running version 11.2.0 or later of SL1 before installing "Jira Service Management Automation Policies" PowerPack version 100.

NOTE: For details on upgrading SL1, see the relevant *SL1 Platform Release Notes*.

Installation the PowerPack

To install this PowerPack:

- 1. Search for and download the PowerPack from the PowerPacks page on the ScienceLogic Support Site.
- 2. In SL1, go to the **PowerPack Manager** page (System > Manage > PowerPacks).
- 3. Click the **Actions** menu and choose *Import PowerPack*. The **Import PowerPack** modal appears.
- 4. Click [Browse] and navigate to the PowerPack file from step 1.
- 5. Select the PowerPack file and click [Import]. The PowerPack Installer modal displays a list of the PowerPack contents.
- 6. Click [Install]. The PowerPack is added to the PowerPack Manager page.

Features

This release includes the following features:

- An example SOAP/XML credential that you can use as a template to send information to PowerFlow.
- Two automation policies that you can configure to update Jira when a user responds to issues in SL1:
 - o Jira: Create Issue
 - o Jira: Timeline Event
- Two action policies that integrates with Jira to automatically update SL1 events and Jira issues:
 - o Jira: Alert
 - o Jira: Create Timeline Event
