Overview

Version 101 of the *Microsoft: Hyper-V* PowerPack addresses an issue in which Dynamic Applications were aligned to Windows Servers that did not have Hyper-V installed and an issue in which regional settings on Windows Servers were not properly translating to SL1.

Before You Install or Upgrade

Ensure that you are running version 8.12.2.7 or later of SL1 before installing the *Microsoft: Hyper-V* PowerPack version 101.

NOTE: For details on upgrading the ScienceLogic platform, see the appropriate ScienceLogic Release Notes.

Installing or Upgrading to Microsoft: Hyper-V PowerPack version 101

TIP: By default, installing a new version of a PowerPack will overwrite all content from that PowerPack that has already been installed on the target system. You can use the *Enable Selective PowerPack Field Protection* setting in the *Behavior Settings* page (System > Settings > Behavior) to prevent the new version of the PowerPack from overwriting local changes for some commonly customized fields.

NOTE: If you are currently using the Dynamic Applications in the *Microsoft: Hyper-V* PowerPack to monitor devices, collection errors might occur for one or two polling cycles during the installation of a new version. To prevent collection errors during an upgrade, you can optionally disable collection for monitored devices before performing the following steps and re-enable collection after the upgrade.

To install the *Microsoft: Hyper-V* PowerPack for the first time or to upgrade from a previous version, perform the following steps:

- 1. See the **Before You Install or Upgrade** section. If you have not done so already, upgrade your system to the 8.12.2.7 or later release.
- 2. Download version 101 of the Microsoft: Hyper-V PowerPack from the Customer Portal to a local computer.
- 3. Go to the **PowerPack Manager** page (System > Manage > PowerPacks). Click the Actions menu and choose *Import PowerPack*. When prompted, import version 101 of the *Microsoft: Hyper-V* PowerPack.
- 4. After importing the PowerPack, you will be prompted to install the PowerPack. Click the Install button to install the PowerPack.
- 5. See the manual Monitoring Windows Systems with PowerShell for instructions on using the PowerPack.

Features

Microsoft: Hyper-V PowerPack version 101 includes the following features:

- Dynamic Applications that collect Hyper-V performance data.
- Event Policies that are triggered when Hyper-V performance metrics meet certain status criteria.

Enhancements and Issues Addressed

The following enhancements and addressed issues are included in version 101 of the Microsoft: Hyper-V PowerPack:

- An issue was addressed in which the "Microsoft: Hyper-V Component Count" and "Microsoft: Hyper-V
 Component Count Configuration" Dynamic Applications were automatically aligned to Windows Servers that
 did not have Hyper-V installed.
- An issue was addressed in which regional settings on Windows Servers that are configured with commas in numerical value formats were not properly translating to SL1.
