

Microsoft: Hyper-V PowerPack Release Notes

## Overview

Version 102 of the Microsoft: Hyper-V PowerPack updates the PowerPack to be Python 3-compatible and updates log messages in a Dynamic Application.

# Before You Install or Upgrade

Ensure that you are running version 12.1.0 or later of SL1 before installing Microsoft: Hyper-V version 102.

NOTE: For details on upgrading SL1, see the appropriate Release Notes.

# Installing or Upgrading the PowerPack

TIP: By default, installing a new version of a PowerPack will overwrite all content in that PowerPack that has already been installed on the target system. You can use the *Enable Selective PowerPack Field Protection* setting in the *Behavior Settings* page (System > Settings > Behavior) to prevent the new version of the PowerPack from overwriting local changes for some commonly customized fields.

**NOTE:** If you are currently using the Dynamic Applications in this PowerPack to monitor devices, collection errors might occur for one or two polling cycles during the installation of a new version. To prevent collection errors during an upgrade, you can optionally disable collection for monitored devices before performing the following steps and re-enable collection after the upgrade.

### To install this PowerPack:

- 1. Familiarize yourself with the *Known Issues* for this release.
- 2. See the **Before You Install or Upgrade** section. If you have not done so already, upgrade your system to the 12.1.0 or later release.
- 3. Download the "Microsoft: Hyper-V" version 102 PowerPack from the Support Site to a local computer.
- 4. Go to the **PowerPack Manager** page (System > Manage > PowerPacks). Click the **[Actions]** menu and choose *Import PowerPack*. When prompted, import "Microsoft: Hyper-V" version 102.
- 5. Click the [Install] button. For details on installing PowerPacks, see the chapter on Installing a PowerPack in the PowerPacks manual.

## **Features**

Version 102 of the Microsoft: Hyper-V PowerPack includes the following features:

- Dynamic Applications that collect Hyper-V performance data.
- Event Policies that are triggered when Hyper-V performance metrics meet certain status criteria.

- Updated the PowerPack to be Python 3-compatible.
