



Microsoft: DHCP Server PowerPack Release Notes

Version 101

Overview

Version 101 of the *Microsoft: DHCP Server* PowerPack updates Dynamic Applications for IPv4 support.

- **Minimum Required SL1 Version:** 11.3.0

Before You Install or Upgrade

Ensure that you are running version 11.3.0 or later of SL1 before installing "Microsoft: DHCP Server" PowerPack version 101.

NOTE: For details on upgrading SL1, see the relevant [SL1 Platform Release Notes](#).

Installing or Upgrading the PowerPack

TIP: By default, installing a new version of a PowerPack will overwrite all content in that PowerPack that has already been installed on the target system. You can use the **Enable Selective PowerPack Field Protection** setting in the **Behavior Settings** page (System > Settings > Behavior) to prevent the new version of the PowerPack from overwriting local changes for some commonly customized fields.

To install version 101 of the *Microsoft: DHCP Server* PowerPack, perform the following steps:

To install this PowerPack:

1. Familiarize yourself with the [Known Issues](#) for this release.
2. See the [Before You Install or Upgrade](#) section. If you have not done so already, upgrade your system to the 11.3.0 or later release.
3. Download the "Microsoft: DHCP Server" version 101 PowerPack from the Support Site to a local computer.
4. Go to the **PowerPack Manager** page (System > Manage > PowerPacks). Click the **[Actions]** menu and choose *Import PowerPack*. When prompted, import "Microsoft: DHCP Server" version 101.
5. Click the **[Install]** button. For details on installing PowerPacks, see the chapter on *Installing a PowerPack* in the **PowerPacks** manual.

Features

This release includes the following features:

- Dynamic Applications that collect DHCP Server performance data.
- Enhanced Dynamic Application functionality for collecting data for multiple scopes.

Enhancements and Issues Addressed

The following enhancements and addressed issues are included this release of the "Microsoft: DHCP Server":

- Addressed an issue in which the "Microsoft: DHCP IPv4 Scope Performance" Dynamic Application issued errors when collecting data for multiple scopes. (Case: 00339981)
