

Microsoft: Exchange Server PowerPack Release Notes

Version 103

## Overview

Version 103 of the "Microsoft: Exchange Server" PowerPack addresses a support defect to restore the *Validity Check* field for nightly discovery and upgrades for Python 3.11 compatibility.

# **Before You Install**

Ensure that you are running version 12.3.1 or later of SL1 before installing the "Microsoft: Exchange Server" PowerPack.

NOTE: For details on upgrading SL1, see the relevant SL1 Platform Release Notes.

# Installation and Upgrade Process

**NOTE:** If you are currently using the Dynamic Applications in this PowerPack to monitor devices, collection errors might occur for one or two polling cycles during the installation of a new version. To prevent collection errors during an upgrade, you can optionally disable collection for monitored devices before performing the following steps and re-enable collection after the upgrade.

#### To install this PowerPack:

- Search for and download the PowerPack from the PowerPacks page (Product Downloads > PowerPacks & SyncPacks) at the ScienceLogic Support Site.
- 2. In SL1, go to the **PowerPacks** page (System > Manage > PowerPacks).
- 3. Click the Actions menu and choose Import PowerPack. The Import PowerPack modal appears.
- 4. Click [Browse] and navigate to the PowerPack file from step 1.
- Select the PowerPack file and click [Import]. The PowerPack Installer modal displays a list of the PowerPack contents.
- 6. Click [Install]. The PowerPack is added to the PowerPack Manager page.

### **Features**

This release includes the following features:

- Dynamic Applications that discover, model, and collect performance and configuration data for Exchange Server performance counters
- Event policies that are triggered when Exchange Server devices meet certain status criteria
- Device classes for each type of Exchange Server device monitored
- · Device templates that align the SL1 Agent to devices

### **Enhancements and Issues Addressed**

The following enhancements and addressed issues are included in this release:

- Updated the PowerPack to include the Validity Check field for discovery objects so that Dynamic Applications only align to the Exchange servers during nightly discovery. (Case: 00519968)
- Updated the PowerPack for Python 3.11 compatibility.

### **Known Issues**

The following known issues affect version 103 of the "Microsoft: Exchange Server" PowerPack:

- Exchange Performance Dynamic Applications will not collect data when ConstrainedLanguage mode is enabled on the Windows server.
- The "Microsoft: Exchange UMS General Performance" Dynamic Application will not align to Microsoft Exchange Server 2019.
