## Overview

Version 100 of the *Microsoft: IIS Server PowerPack* is an upgrade from version 1.0. Version 100 has been updated to support Microsoft Windows IIS 10.0 and includes several updates to the PowerPack's Dynamic Applications.

- **Minimum Required Platform Version:** 8.7.0
- **Support Status:** GA

## Before You Install or Upgrade

Ensure that you are running version 8.7.0 or later of the ScienceLogic platform before installing the *Microsoft: IIS Server PowerPack* version 100.

**NOTE:** For details on upgrading the ScienceLogic platform, see the appropriate ScienceLogic [Release Notes](#).

## Installing or Upgrading to Microsoft: IIS Server PowerPack version 100

**TIP:** By default, installing a new version of a PowerPack will overwrite all content from that PowerPack that has already been installed on the target system. You can use the **Enable Selective PowerPack Field Protection** setting in the **Behavior Settings** page (System > Settings > Behavior) to prevent the new version of the PowerPack from overwriting local changes for some commonly customized fields.

**NOTE:** If you are currently using the Dynamic Applications in the *Microsoft: IIS Server PowerPack* to monitor devices, collection errors might occur for one or two polling cycles during the installation of a new version. To prevent collection errors during an upgrade, you can optionally disable collection for monitored devices before performing the following steps and re-enable collection after the upgrade.

To install the *Microsoft: IIS Server* PowerPack for the first time or to upgrade from a previous version, perform the following steps:

1. See the [Before You Install or Upgrade](#) section. If you have not done so already, upgrade your system to the 8.7.0 or later release.
2. Download version 100 of the *Microsoft: IIS Server* PowerPack from the Customer Portal to a local computer.
3. Go to the **PowerPack Manager** page (System > Manage > PowerPacks). Click the **[Actions]** menu and choose *Import PowerPack*. When prompted, import version 100 of the *Microsoft: IIS Server* PowerPack.
4. After importing the PowerPack, you will be prompted to install the PowerPack. Click the **[Install]** button to install the PowerPack.
5. See the manual *Monitoring Windows Systems* for instructions on using the PowerPack.

## Features

*Microsoft: IIS Server* PowerPack version 100 includes the following features:

- Dynamic Applications that collect Microsoft Internet Information Services (IIS) configuration information and performance metrics for Windows Servers
- Event Policies that are triggered when IIS services meet certain status criteria

## Enhancements and Issues Addressed

The following enhancements and addressed issues are included in version 100 of the *Microsoft: IIS Server* PowerPack:

- The "Microsoft: IIS Active Server Pages Performance" Dynamic Application was updated to include a new "Session Timed Out" collection object that tracks the number of sessions that have timed out.
- The "Microsoft: IIS Server Configuration" Dynamic Application was updated to address an issue with the "Discovery" collection object's PowerShell request.
