#### Overview

Version 101 of the Microsoft: IIS Server PowerPack adds a new Dynamic Application to collect the run-time state of application pools from Microsoft Internet Information Services (IIS).

• Minimum Required Platform Version: 8.7.0

• Support Status: GA

## Before You Install or Upgrade

Ensure that you are running version 8.7.0 or later of the ScienceLogic platform before installing the *Microsoft: IIS* Server PowerPack version 101.

NOTE: For details on upgrading the ScienceLogic platform, see the appropriate ScienceLogic Release Notes.

# Installing or Upgrading to Microsoft: IIS Server PowerPack version 101

TIP: By default, installing a new version of a PowerPack will overwrite all content from that PowerPack that has already been installed on the target system. You can use the *Enable Selective PowerPack Field Protection* setting in the *Behavior Settings* page (System > Settings > Behavior) to prevent the new version of the PowerPack from overwriting local changes for some commonly customized fields.

NOTE: If you are currently using the Dynamic Applications in the Microsoft: IIS Server PowerPack to monitor devices, collection errors might occur for one or two polling cycles during the installation of a new version. To prevent collection errors during an upgrade, you can optionally disable collection for monitored devices before performing the following steps and re-enable collection after the upgrade.

To install the Microsoft: IIS Server PowerPack for the first time or to upgrade from a previous version, perform the following steps:

- 1. See the **Before You Install or Upgrade** section. If you have not done so already, upgrade your system to the 8.7.0 or later release.
- 2. Download version 101 of the Microsoft: IIS Server PowerPack from the Customer Portal to a local computer.
- 3. Go to the **PowerPack Manager** page (System > Manage > PowerPacks). Click the **[Actions]** menu and choose *Import PowerPack*. When prompted, import version 101 of the *Microsoft: IIS Server PowerPack*.
- 4. After importing the PowerPack, you will be prompted to install the PowerPack. Click the **[Install]** button to install the PowerPack.
- 5. See the manual *Monitoring Windows Systems* for instructions on using the PowerPack.

### **Features**

Microsoft: IIS Server PowerPack version 101 includes the following features:

- Dynamic Applications that collect configuration information and performance metrics for Microsoft Internet Information Services (IIS) running on Windows Servers
- Event Policies that are triggered when IIS services meet certain status criteria

## Enhancements and Issues Addressed

The following enhancements and addressed issues are included in version 101 of the Microsoft: IIS Server PowerPack:

 The "Microsoft: IIS Application Pool Status" Dynamic Application was added that collects Microsoft Internet Information Services (IIS) Application Pool configuration information and events when Application Pools are not started.
