## Before You Install

Ensure that you are running version 10.1.0 or later of SL1 before installing *NetApp Automation Policies* version 101.

# Installation Process

To install version 101 of the NetApp Automation Policies PowerPack, perform the following steps:

- 1. See the **Before You Install** section. If you have not done so already, upgrade your system to the 10.1.0 or later release.
- 2. Download the NetApp Automation Policies version 101 PowerPack to a local computer.
- 4. Go to the **PowerPack Manager** page (System > Manage > PowerPacks). Click the **[Actions]** menu and choose *Import PowerPack*. Import the *NetApp Automation Policies*version 101 PowerPack. For details on importing PowerPacks, see the chapter on *Installing a PowerPack* in the **PowerPacks** manual.
- 5. Click the [Install] button. For details on installing PowerPacks, see the chapter on Installing a PowerPack in the PowerPacks manual.
- 6. See the **Run Book Automation** manual for instructions on using Action Type contained in the new PowerPack.
