Overview

Version 100 is the initial version of the NGINX: Open Source and Plus PowerPack.

• Minimum Required Platform Version: 8.7.0

• Support Status: Beta

Before You Install

Ensure that you are running 8.7.0 or later of SL1 before installing the NGINX: Open Source and Plus PowerPack version 100.

NOTE: For details on upgrading SL1, see the appropriate SL1 Release Notes.

Installing NGINX: Open Source and Plus PowerPack version 100

To install the NGINX: Open Source and Plus PowerPack for the first time, perform the following steps:

- 1. See the **Before You Install** section. If you have not done so already, upgrade your SL1 system to the 8.7.0 or later release.
- 2. Download version 100 of the NGINX: Open Source and Plus PowerPack from the Customer Portal to a local computer.
- 3. Go to the **PowerPack Manager** page (System > Manage > PowerPacks). Click the **[Actions]** menu, and choose *Import PowerPack*. When prompted, import version 100 of the *NGINX*: Open Source and Plus PowerPack.
- 4. After importing the PowerPack, you will be prompted to install the PowerPack. Click the **[Install]** button to install the PowerPack.
- 5. See the manual *Monitoring NGINX* for instructions on using the PowerPack.
