Version 100

Overview

Version 100 of the NVIDIA GPU PowerPack is the initial version of the PowerPack. With this PowerPack, you can monitor your NVIDIA GPU devices in real time.

Before You Install or Upgrade

Ensure that you are running version 11.3.0 or later of SL1 before installing "NVIDIA GPU" PowerPack version 100.

NOTE: For details on upgrading SL1, see the relevant SL1 Platform Release Notes.

Installation and Upgrade Process

NOTE: If you are currently using the Dynamic Applications in this PowerPack to monitor devices, collection errors might occur for one or two polling cycles during the installation of a new version. To prevent collection errors during an upgrade, you can optionally disable collection for monitored devices before performing the following steps and re-enable collection after the upgrade.

To install this PowerPack:

- Search for and download the PowerPack from the PowerPacks page (Product Downloads > PowerPacks & SyncPacks) at the <u>ScienceLogic Support Site</u>.
- 2. In SL1, go to the **PowerPacks** page (System > Manage > PowerPacks).
- 3. Click the Actions menu and choose Import PowerPack. The Import PowerPack modal appears.
- 4. Click [Browse] and navigate to the PowerPack file from step 1.
- 5. Select the PowerPack file and click [Import]. The PowerPack Installer modal displays a list of the PowerPack contents.
- 6. Click [Install]. The PowerPack is added to the PowerPack Manager page.

This release includes the following features:

- The following Dynamic Applications that discover and collect data from NVIDIA GPU:
 - o Nvidia: Card Configuration
 - o Nvidia: Card Performance
 - ° Nvidia: Memory Performance
- Event Policies and corresponding alerts that are triggered when NVIDIA GPU devices meet certain status criteria
- A sample SSH Credential ("Nvidia GPU Monitoring Example") that you can use to create your own NVIDIA Credential
- A Device Template ("Nvidia GPU Monitor Template") that aligns NVIDIA Dynamic Applications with devices
