Version 100

Overview

Version 100 of the *Polycom Infrastructure* PowerPack is an update from version 7.8.0 of the PowerPack. This version includes a security update.

Before You Install or Upgrade

Ensure that you are running version 10.1.0 or later of SL1 before installing Polycom Infrastructure version 100.

NOTE: For details on upgrading SL1, see the appropriate Release Notes.

Installing or Upgrading to Polycom Infrastructure PowerPack version 100

To install or upgrade the Polycom Infrastructure PowerPack, perform the following steps:

- 1. Familiarize yourself with the *Known Issues* for this release.
- 2. See the **Before You Install or Upgrade** section. If you have not done so already, upgrade your system to the 10.1.0 or later release.
- 3. Download Polycom Infrastructure version 100 from the Support Site to a local computer.
- 4. Go to the **PowerPack Manager** page (System > Manage > PowerPacks). Click the Actions menu and choose *Import PowerPack*. When prompted, import *Polycom Infrastructure* version 100.
- 5. Click the Install button. For details on installing PowerPacks, see the chapter on *Installing a PowerPack* in the *PowerPacks* manual.

Features

Version 100 of the Polycom Infrastructure PowerPack includes the following features:

- Dynamic Applications that collect information about Polycom infrastructure devices
- Event Policies that are triggered when Polycom infrastructure devices meet certain status criteria
- Device Classes for each type of Polycom infrastructure device monitored
- Sample credentials for discovering Polycom infrastructure devices

Enhancements and Issues Addressed

The following enhancements and addressed issues are included in version 100 of the *Polycom Infrastructure* PowerPack:

- Snippet logging was updated in the following Dynamic Applications to ensure that usernames, passwords, API keys, or authorization tokens are hidden:
 - o Polycom RMX: Conference CDR
 - Polycom RMX: Fault Log
 - o Polycom RMX: IP Network Properties
 - Polycom RMX: ISDN Properties
 - Polycom RMX: Management Network Properties
 - Polycom RMX: Participant CDR
 - Polycom RMX: Resource Utilization Cache
 - o Polycom RMX: System Information
