



Restorepoint PowerPack

Release Notes Version 106

Overview

Version 106 of the "Restorepoint" PowerPack updates the Dynamic Applications in the PowerPack to use the SHA algorithm to improve security and address an issue that caused the connection to fail.

This PowerPack works in conjunction with the "Restorepoint" SyncPack.

System Requirements

The "Restorepoint" PowerPack requires:

- SL1 PowerFlow platform version 2.6.0 or later.
- SL1 version 12.3.x or later. For details on upgrading SL1, see the relevant [SL1 Platform Release Notes](#).
- Restorepoint version 5.5.x or later.

Installing the PowerPack

TIP: By default, installing a new version of a PowerPack will overwrite all content in that PowerPack that has already been installed on the target system. You can use the **Enable Selective PowerPack Field Protection** setting in the **Behavior Settings** page (System > Settings > Behavior) in SL1 to prevent the new version of the PowerPack from overwriting local changes for some commonly customized fields.

NOTE: If you are currently using the Dynamic Applications in this PowerPack to monitor devices, collection errors might occur for one or two polling cycles during the installation of a new version. To prevent collection errors during an upgrade, you can optionally disable collection for monitored devices before performing the following steps and re-enable collection after the upgrade.

To install this PowerPack:

1. Search for and download the PowerPack from the **PowerPacks** page (Product Downloads > PowerPacks & SyncPacks) at the [ScienceLogic Support Site](#).
2. In SL1, go to the **PowerPacks** page (System > Manage > PowerPacks).
3. Click the **Actions** menu and choose *Import PowerPack*. The **Import PowerPack** modal appears.

4. Click **[Browse]** and navigate to the PowerPack file from step 1.
5. Select the PowerPack file and click **[Import]**. The **PowerPack Installer** modal displays a list of the PowerPack contents.
6. Click **[Install]**. The PowerPack is added to the **PowerPack Manager** page.
