## Overview

Version 100 is the initial version of the *VMware User-Initiated Automation* PowerPack. This PowerPack adds automation policies that allow a user to manually run automation actions from the *VMware Automation* PowerPack from the event console.

**NOTE:** This PowerPack is intended to supplement the *VMware Automation* PowerPack.

## Before You Install

Ensure that you are running version 10.1.0 or later of SL1 and have installed the *VMware Automation* PowerPack before installing the *VMware User-Initiated Automation* PowerPack.

**IMPORTANT:** To provide output formatting in HTML or plaintext, you must also install the *Datacenter Automation Utilities* PowerPack.

## Installation Process

To install version 100 of the *VMware User-Initiated Automation* PowerPack:

1. See the [Before You Install](#) section. If you have not done so already, upgrade your system to the 10.1.0 or later release.
2. Download the *VMware User-Initiated Automation* version 100 PowerPack to a local computer.
4. Go to the **PowerPack Manager** page (System > Manage > PowerPacks). Click the **[Actions]** menu and choose *Import PowerPack*. Import the *VMware User-Initiated Automation* version 100 PowerPack. For details on importing PowerPacks, see the chapter on *Installing a PowerPack* in the **PowerPacks** manual.

5. Click the **[Install]** button. For details on installing PowerPacks, see the chapter on *Installing a PowerPack* in the **PowerPacks** manual.
6. See the **VMware Automation PowerPacks** manual for instructions on using the new PowerPack.
