# VOSS Insights: Appliance Monitoring PowerPack Release Notes

Version 102

---

## Overview

Version 102 of the *VOSS Insights: Appliance Monitoring* PowerPack addresses an issue in which Dynamic Applications were not collecting data due to an erroneous space in the credential header.

- **Minimum Required SL1 Version:** 11.2.0

**NOTE:** The *LayerX Appliance Monitoring* PowerPack was rebranded as the *VOSS Insights: Appliance Monitoring* PowerPack.

## Before You Install or Upgrade

Ensure that you are running version 11.2.0 or later of SL1 before installing *VOSS Insights: Appliance Monitoring* version 102.

**NOTE:** For details on upgrading SL1, see the appropriate [Release Notes](#).

## Installation and Upgrade Process

**TIP:** By default, installing a new version of a PowerPack will overwrite all content in that PowerPack that has already been installed on the target system. You can use the **Enable Selective PowerPack Field Protection** setting in the **Behavior Settings** page (System > Settings > Behavior) to prevent the new version of the PowerPack from overwriting local changes for some commonly customized fields.

**NOTE:** If you are currently using the Dynamic Applications in this PowerPack to monitor devices, collection errors might occur for one or two polling cycles during the installation of a new version. To prevent collection errors during an upgrade, you can optionally disable collection for monitored devices before performing the following steps and re-enable collection after the upgrade.

To install this PowerPack:

1. Familiarize yourself with the [Known Issues](#) for this release.
2. See the [Before You Install or Upgrade](#) section. If you have not done so already, upgrade your system to the 11.2.0 or later release.
3. Download the *VOSS Insights: Appliance Monitoring* version 102 PowerPack from the Support Site to a local computer.
4. Go to the **PowerPack Manager** page (System > Manage > PowerPacks). Click the **[Actions]** menu and choose *Import PowerPack*. When prompted, import *VOSS Insights: Appliance Monitoring* version 102.
5. Click the **[Install]** button. For details on installing PowerPacks, see the chapter on *Installing a PowerPack* in the **PowerPacks** manual.

## Features

Version 102 of the *VOSS Insights: Appliance Monitoring* PowerPack includes the following features:

- Dynamic Applications that discover and monitor VOSS Insights appliances
- Device Classes for each type of VOSS Insights appliance monitored
- Device Templates for monitoring VOSS Insights Arbitrator appliances and VOSS Insights Reporter appliances
- Event Policies and corresponding alerts that are triggered when VOSS Insights appliances meet certain status criteria
- A sample Credential for discovering VOSS Insights appliances
- A Credential Test to validate credentials
- Run Book Actions and an Automation Policy to create the device, test collection, check the Credential, and apply a Device Template

## Enhancements and Issues Addressed

The following enhancements and addressed issues are included in version 102 of the *VOSS Insights: Appliance Monitoring* PowerPack:

- The *LayerX Appliance Monitoring* PowerPack was rebranded as the *VOSS Insights: Appliance Monitoring* PowerPack.
- An issue was addressed in which Dynamic Applications were not collecting any data due to a space in the "Content-type" credential header of the "VOSS Insights: Appliance Sample" credential.
