## Overview

Version 101 of the *Microsoft*: *Windows Server Event Logs* PowerPack has been updated to be compliant with Python 3 and had silo\_apps libary added to the PowerPack.

## Before You Install or Upgrade

Ensure that you are running version 12.1.0 or later of SL1 before installing the Microsoft: Windows Server Event Logs PowerPack version 101.

**NOTE**: For details on upgrading SL1, see the appropriate SL1 <u>Release Notes</u>.

## Installing or Upgrading to Microsoft: Windows Server Event Logs PowerPack version 101

TIP: By default, installing a new version of a PowerPack will overwrite all content in that PowerPack that has already been installed on the target system. You can use the *Enable Selective PowerPack Field Protection* setting in the **Behavior Settings** page (System > Settings > Behavior) to prevent the new version of the PowerPack from overwriting local changes for some commonly customized fields.

**NOTE:** If you are currently using the Dynamic Applications in the *Microsoft: Windows Server Event Logs* PowerPack to monitor devices, collection errors might occur for one or two polling cycles during the installation of a new version. To prevent collection errors during an upgrade, you can optionally disable collection for monitored devices before performing the following steps and re-enable collection after the upgrade.

To install the *Microsoft*: *Windows Server Event Logs* PowerPack for the first time or to upgrade from a previous version, perform the following steps:

- 1. See the **Before You Install or Upgrade** section. If you have not done so already, upgrade your system to the 12.1.0 or later release.
- 2. Familiarize yourself with the Known Issues for this release.
- 3. Download version 101 of the Microsoft: Windows Server Event Logs PowerPack from the Support Site to a local computer.
- Go to the PowerPack Manager page (System > Manage > PowerPacks). Click the [Actions] menu and choose Import PowerPack. When prompted, import version 101 of the Microsoft: Windows Server Event Logs PowerPack.
- 5. After importing the PowerPack, you will be prompted to install the PowerPack. Click the **[Install]** button to install the PowerPack.
- 6. See the manual *Monitoring Windows Services with PowerShell* for instructions on using the PowerPack.

## Features

Microsoft: Windows Server Event Logs PowerPack version 101 includes the following features:

- Dynamic Applications that discover and collect data from Microsoft Windows Server event logs:
  - Microsoft: Windows Server Application Events
  - Microsoft: Windows Server Security Events
  - Microsoft: Windows Server System Events
- Event Policies and corresponding alerts that are triggered when Microsoft Windows Server event logs meet certain status criteria
