Overview

Version 105 of the *Dell EMC: XtremIO* PowerPack includes improvements to various Dell EMC XtremIO Dynamic Applications.

- **Minimum Required Platform Version:** 8.2.0
- **Support Status:** GA
- **Other Key Information:** When configuring a discovery session for an XtremIO system:
 - The **Initial Scan Level** setting must be set to 5. *Deep Discovery*
 - The **Detection Method & Port** field must include *TCP: 443 - https*

Before You Install or Upgrade

Ensure that you are running ScienceLogic system version 8.2.0 or later before installing the *Dell EMC: XtremIO* PowerPack version 105.

NOTE: For details on upgrading the ScienceLogic platform, see the appropriate [ScienceLogic Release Notes](#).

Installing or Upgrading to Dell EMC: XtremIO PowerPack version 105

TIP: By default, installing a new version of a PowerPack will overwrite all content in that PowerPack that has already been installed on the target system. You can use the **Enable Selective PowerPack Field Protection** setting in the **Behavior Settings** page (System > Settings > Behavior) to prevent the new PowerPack from overwriting local changes for some commonly customized fields.

NOTE: If you are currently using the Dynamic Applications in the *Dell EMC: XtremIO PowerPack* to monitor devices, collection errors might occur for one or two polling cycles during the installation of a new version. To prevent collection errors during an upgrade, you can optionally disable collection for monitored devices before performing the following steps and re-enable collection after the upgrade.

To install the *Dell EMC: XtremIO PowerPack* for the first time or to upgrade from a previous version:

1. See the [Before You Install or Upgrade](#) section. If you have not done so already, upgrade your system to the 8.2.0 or later release.
2. Download version 105 of the *Dell EMC: XtremIO PowerPack* from the [Customer Portal](#) to a local computer.
3. Go to the **PowerPack Manager** page (System > Manage > PowerPacks). Click the **[Actions]** menu and choose *Import PowerPack*. When prompted, import version 105 of the PowerPack.
4. Click the **[Install]** button. For details on installing PowerPacks, see the chapter on *Installing a PowerPack* in the **PowerPacks** manual.

Features

Dell EMC: XtremIO PowerPack version 105 includes the following features:

- Dynamic Applications that discover and collect data from Dell EMC XtremIO storage devices
- Event Policies that are triggered when XtremIO storage devices meet certain status criteria
- Device Classes for each type of XtremIO storage device monitored
- A sample credential for discovering XtremIO storage devices

Enhancements and Issues Addressed

The following enhancements and addressed issues are included in version 105 of the *Dell EMC: XtremIO PowerPack*:

- The "Dell EMC: XtremIO Initiator and Initiator Group" Dynamic Application was renamed "Dell EMC: XtremIO Initiator and Initiator Group Config".
- The "Dell EMC: XtremIO X-Brick Discovery", "Dell EMC: XtremIO LUN Discovery", and "Dell EMC: XtremIO LUN Performance and Capacity Stats" Dynamic Applications were updated to add support for multiple clusters per XMS.
- The "Dell EMC: XtremIO LUN Performance and Capacity Stats" Dynamic Application was updated to handle bulk performance data.
- The PowerPack's Dynamic Applications were updated to improve the handling of performance data.
