## Overview

Version 100 of the "Zebrium Event Policies" PowerPack is the initial version of the PowerPack. Version 100 includes a set of event policies that change Zebrium alerts into SL1 events. You can monitor these events on the **Events** page, **Event Investigator** page, the **Device Investigator** page, and the **System Investigator** page in SL1.

To install this PowerPack:

2. Download the "Zebrium Event Policies" PowerPack from the Support Site to a local computer.
3. Go to the **PowerPack Manager** page (System > Manage > PowerPacks). Click the **[Actions]** menu and choose *Import PowerPack*.
4. When prompted, import the PowerPack.
5. Click the **[Install]** button. For details on installing PowerPacks, see the chapter on *Installing a PowerPack* in the **PowerPacks** manual.
