



CLI: Toolkit PowerPack Release Notes

Version 101

Overview

Version 101 of the "CLI: Toolkit" PowerPack includes an updated execution environment.

- **Minimum Required Platform Version:** 11.3.0

Before You Install or Upgrade

Ensure that you are running version 11.3.0 or later of SL1 before installing or upgrading to the "CLI: Toolkit" PowerPack version 101.

Installing or Upgrading the PowerPack

To install the "CLI: Toolkit" PowerPack, perform the following steps:

TIP: By default, installing a new version of a PowerPack will overwrite all content in that PowerPack that has already been installed on the target system. You can use the **Enable Selective PowerPack Field Protection** setting in the **Behavior Settings** page (System > Settings > Behavior) to prevent the new version of the PowerPack from overwriting local changes for some commonly customized fields.

NOTE: If you are currently using the Dynamic Applications in the PowerPack to monitor devices, collection errors might occur for one or two polling cycles during the installation of a new version. To prevent collection errors during an upgrade, you can optionally disable collection for monitored devices before performing the following steps and re-enable collection after the upgrade.

1. See the [Before You Install or Upgrade](#) section. If you have not done so already, upgrade your system to 11.3.0 or later release.
2. Download the latest version of the "CLI: Toolkit" PowerPack from the Support Site to a local computer.
3. Go to the **PowerPack Manager** page (System > Manage > PowerPacks). Click the **[Actions]** menu and select *Import PowerPack*. When prompted, import this version of the "CLI: Toolkit" PowerPack.
4. After importing the PowerPack, you will be prompted to install the PowerPack. Click the **[Install]** button to install the PowerPack.

Features

This release of the "CLI: Toolkit" PowerPack includes the following features:

- An execution environment with CLI/SSH steps for building Dynamic Applications for CLI/SSH devices.
- A template Dynamic Application that demonstrates the CLI steps.

Enhancements and Issues Addressed

The following enhancements and addressed issues are included in this release of the "CLI: Toolkit" PowerPack:

- The execution environment included in the PowerPack was updated to specify each ScienceLogic Library that it uses.
